## Notification of Line Charge Changes

Pursuant to the Electricity Information Disclosure Requirements 2004, OtagoNet Limited hereby gives notice that the following line charges will apply for Installation Control Points (ICPs) as from 1 April 2010.

The new and existing line charges for ICPs in the OtagoNet area are shown below:

The line charges do not include metering charges and are GST exclusive.

Electricity consumers should note that these are the line charges as charged to the electricity retailers. Individual electricity retailers will make their own decisions whether to adjust their retail prices to consumers to reflect any changes in the line charges.

Value of the network components allocated based on the current ORC valuation Proportion of the Transpower charges based on their capacity and demand and the Transpower grid exit charges. Presently there are seven major customers to which these major customer charges apply.

### Definitions:

**Assessed kVA Demand** means the maximum average electrical demand over any half-hour period measured in kVA. This may be measured by half-hour demand metering or measured by portable logging equipment or assessed from nameplate ratings of connected equipment.

**Summer Day** means the period of time from 07:00 until 23:00 on all days between the 1st of October and 30th of April.

**Winter Day** means the period of time from 07:00 until 23:00 on all days between the 1st of May and the 30th September.

**Night** means the period of time from 23:00 until 07:00 on all nights of the year.

**Grid Exit Point** means the Transpower substation that supplies the customer. The Retailer's energy for classes 1, 2, 5 & 6 is calculated by subtracting the day and night kWh figures, plus losses, of the maximum demand, major customers and 10% Fixed Charge Option from the Retailer's reconciled energy at each grid exit point.

**Loss Factors** - The loss factor for all ICP's except the major customers is 1.0750. Major customers have individual loss factors.
