



Smart Energy Home Project - Terms & Conditions

These Terms and Conditions shall apply and regulate the submission of applications for the Promotion:

- 1.1 All applications for the Promotion must be submitted on the prescribed pre-tenancy application form no later than 12 pm on Wednesday 13 March 2019.
- 1.2 The Promoters are not bound to accept or consider any applications received after the closure of the application period, however the Promoters may extend the application period at their unilateral discretion by notification on their website www.powernet.co.nz
- 1.3 Ineligible Participants are not able to participate in this Promotion.
- 1.4 All applicant details must be valid and up-to-date at the time of submitting the application. The Promoter shall not be obliged to consider any application that is incomplete, has omissions or where there has been falsification of any information supplied with the application or incorrectly submitted.
- 1.5 Applicants shall be deemed to have approved and accepted the Terms and Conditions upon submission of their application to the Promoters.
- 1.6 The Promoter is not obliged to accept any application submitted. Applications will be considered by the Promoters at the Promoter's sole discretion.
- 1.7 Should the Promoters select an applicant to participate in the Promotion, the selected applicant shall be contacted via the applicant's submitted contact details no later than 12 noon on Tuesday 19th March 2019 (unless the application period is extended in accordance with clause 1.2). The selected applicant shall have five (5) working days

from notification of the approval of their application by the Promoters to complete, validly execute and return the Promotion Documents.

1.8 If a selected applicant does not validly execute or return to the Promoters the Promotion Documents within the prescribed timeframe in clause 1.8, it shall be deemed that the applicant has withdrawn their application from the Promotion. The Promoter may then reconsider all applications and select a further applicant to participate in the Promotion and so on at the sole discretion of the Promoters.

1.9 The Promoters may at any time and at the Promoter's sole discretion, terminate the Promotion by notification on the website www.powernet.co.nz

1.10 Applicants are deemed to have approved (without amendment), the terms of the Promotion Documents.

1.11 **Definitions**

In these terms and conditions, unless the context requires:

"Immediate Family Members" means spouses, de facto partners, grandparents, parents, brothers and sisters, children and grandchildren, whether by marriage, past marriages, re-marriage, adoption, cohabitation or family extension of an employee or director of PowerNet;

"Ineligible Participant" means any employee or director of PowerNet or any Immediate Family Member;

"PowerNet" means PowerNet Limited and any Subsidiary or Related Company of PowerNet Limited;

"Promoters" is a joint reference to PowerNet Limited and The Power Company Limited;

"Promotion" means the Smart Energy Home Promotion undertaken by the Promoters;

"Promotion Documents" means the Tenancy Agreement and Promotional Services Deed prepared by the Promoters for this Promotion.

"Related Company" has the same meaning as set out in section 2 of the Companies Act 1993;

"Subsidiary" has the same meaning as set out in section 5 of the Companies Act 1993;

"Terms and Conditions" means these terms and conditions regulating applications for the Promotion.
