Pursuant to the Electricity Distribution Information Disclosure Determination 2012, Electricity Invercargill Limited hereby gives notice that the following line charges will apply for Installation Control Points (ICPs) as from 1 April 2014.

Pursuant to clause 2.4.19.(1)(b) of the Electricity Distribution Information Disclosure Determination 2012, new charges reflect an increase in Transmission charges and an increase in Distribution charges as allowed by the Commerce Commission under its Default Price-Quality Path, which allows us to operate and maintain the network to a safe and reliable standard.

The line charges do not include metering charges and are GST exclusive.

Variable Charges

The variable rates shown apply to the Day MWh Purchases as metered at the Transpower Grid Supply Point.

Day is defined as 0700 - 2300 hours.
