

Electricity Invercargill Limited

Non Half Hour Metered Individual Customer Charges from 1 April 2015

Pursuant to the Electricity Distribution Information Disclosure Determination 2012, Electricity Invercargill Limited hereby gives notice that the following line charges will apply for Installation Control Points (ICPs) as from 1 April 2015.

Pursuant to clause 2.4.19.(1)(b) of the Electricity Distribution Information Disclosure Determination 2012, new charges reflect a decrease in Transmission charges and a decrease in Distribution charges as determined by the Commerce Commission in its reset of the Default Price-Quality Path. Changes to total line charges also reflect the changes in individual ICP's peak demand and consumption levels as metered in the previous 12 month assessment period.

The line charges do not include metering charges and are GST exclusive.
