Non Half Hour Metered Individual Customer Prices from 1 April 2025

Pursuant to The Electricity Distribution Information Disclosure Determination 2012.

Pursuant to clause 2.4.19.(1)(b) of the Electricity Distribution Information Disclosure Determination 2012, new charges reflect a change in Transpower line pricing methodology and an increase in Distribution charges as determined by the Commerce Commission in its Default Price-Quality Path. Changes to total line prices also reflect the changes in individual ICP's peak demand and consumption levels as metered in the previous 12 month assessment period.

The reported line charges do not include metering charges and are GST exclusive.
